CREDIT AGREEMENT

The foregoing statements are being provided for the purpose of obtaining credit. I certify, both individually and as the authorized representative of the Applicant, that Delta Fuel Company, LLC. may undertake a credit investigation of the Applicant and Guarantor(s). By signing as this application, the Applicant agrees to the terms of this Agreement. This is not a commitment to lend. All Applicants are subject to approval by Delta Fuel. Delta Fuel Company, LLC and Applicant/Guarantors agree that facsimile signatures are equivalent to an original signature and are binding to all parties. Delta Fuel's duty to sale and Applicant's right to purchase hereunder are at all times subject to Delta Fuel's approval, and continuing approval, of Applicant's credit with Delta Fuel. No assurance or guarantee is made of Applicant's credit with Delta Fuel or continuation thereof; and Delta Fuel reserves the right, without limitation, to sell on pre-paid, COD, standby letter of credit, or other secured or collaterally assured basis acceptable to Delta Fuel. Without limitation on Delta Fuel's rights and remedies against Applicant, if Buyer fails to promptly pay any amount due to Delta Fuel or if Delta Fuel needs assurance, or further assurance, of Applicant's credit worthiness, Delta Fuel may cancel this Agreement, demand different payment terms, suspend or recall deliveries or shipments, impose different credit terms, or impose different requirements for collateral assurance of payment.

The Applicant agrees to pay Delta Fuel Company, LLC. the full amount of all credit advances that are made to the Applicant. In making this application, Applicant understands that all invoices for goods or products purchased by Applicant must be paid pursuant to the terms stated on said invoice. If an invoice is not paid on or before the due date, the invoice is delinquent. For any delinquent invoice or balance, Delta Fuel, at its discretion, may impose a monthly finance charge at the maximum interest rate permitted by law or 1 1/2% per month (18% per annum) if the maximum legal interest rate exceeds 18%. A \$40.00 handling fee shall be assessed for any NSF, dishonored, or cancelled checks. Applicant shall pay all costs, commissions, expenses and attorney fees incurred by Delta Fuel relating to the collection of any amount due, including all attorney fees and costs incurred by Delta in any suit, arbitration, mediation, bankruptcy proceeding, and post-judgment proceeding. Applicant hereby grants Delta Fuel Company, LLC. a security interest in all products and equipment Applicant purchases from Delta Fuel Company, LLC. together with all proceeds, products and replacements relating to such products and equipment, to secure payment of all amounts due from Applicant to Delta Fuel Company, LLC. A copy of this Agreement may be filed as a financing statement wherein Applicant is the debtor and Delta Fuel Company, LLC. is the secured party.

Any disputes to an invoice must be reduced to writing and delivered via certified mail, Attn: Credit Manager, within thirty (30) days of issuance of the disputed invoice or applicant waives its right to do so. Applicant agrees that any notation on a check that states "payment in full" or other language whose intent is to compromise any amount owed to Delta Fuel is to be disregarded, as Applicant waives any right to claim a compromise under Louisiana Civil Code Art. 3071 et seq., or similar provisions under the Uniform Commercial Code pertaining to accord and satisfaction rules. Any settlement or compromise of any debt owed to Delta Fuel must be in writing and signed by Delta Fuel's Credit Manager or a company officer. Furthermore, any offer to compromise, including correspondence attached to checks marked 'payment in full,' must also be sent via certified mail to the address and attention above.

Goods sold by Delta Fuel Company, LLC are products of reputable manufacturers. Except as to title, THERE ARE NO WARRANTIES, EITHER WRITTEN, ORAL, IMPLIED, OR STATUTORY relating to the described goods which extend beyond that described in this paragraph. NO IMPLIED STATUTORY WARRANTY OF MERCHANTABILITY OR FITNESS FOR PARTICULAR PURPOSE SHALL APPLY. In no event shall Delta Fuel have any responsibility or bear any liability for the cost of labor for the repair of any defective goods, or the removal of defective goods or products. In no event shall Delta Fuel Company, LLC be liable to Applicant for any punitive, exemplary, indirect, or consequential losses, damages (including delay, loss of business, loss of profits), liabilities or expenses howsoever arising. Furthermore, Delta Fuel's liability to Applicant for any claim or dispute shall be limited to the total of the amounts paid by Applicant to Delta Fuel in the six (6) month period immediately prior to the dispute. Applicant acknowledges that any goods returned, if permitted by Delta Fuel, are subject to a restocking charge.
